Several volunteers showed up to blaze the new trail, and another thank you to Jim Lanou for showing up with his excavator again.

Whereas there is a snow storm predicted for tomorrow, work bees were not discussed today, however there are reported trees down and other blockage on the Gilman/Potato Hill trails as well as on Gove/Potato Hill trails. Also, Bill said there's a bridge on Potato Hill that was put in as a temporary fix several years ago that is now in pieces.

Old Business:

The club will be purchasing durable plastic trail signs made by Northern Light Etchings. Eric brought in a sample sign, and a committee of Eric, Terry, Earl, Mark and Matt was formed to get together on Tuesday night at 7 pm to discuss various formats and ideas of what junctions need signs first and what should be on these signs. Next year, the club may ask if anyone would like to "adopt" a trail or junction to help maintain these areas.
